VII. SUPERINTENDENT REPORT

Ms. Somers reported the success of the second annual Multicultural Day which was held at Noecker School and the Roseland Library! Both were amazing events and anticipation is high for next year.

In addition to Multicultural Day, Ms. Somers spoke of other April traditions including the 6th grade Wax Museum and the 2nd grade Arbor Day/Earth Day program. These were so engaging and well-done. Our students are quite the performers!

Earlier in April, the district successfully participated in state monitoring known as QSAC. Visitors from the county office were very impressed with our facilities, curriculum, and the professionalism of our staff. Ms. Somers shared that she was very proud to share our collective work in governance, personnel, curriculum and instruction, fiscal management, and operations.

Now that May has arrived, it's assessment season with NJSLA, previously known as PARCC, beginning today and Kindergarten Assessments for next year's class begins tomorrow. It looks like we have 53 incoming kindergartners so far.


