Anti-Bullying Bill of Rights (ABR) Act

The goal of the ABR Act was to strengthen the standards and procedures for preventing, reporting, investigating and responding to incidents of harassment, intimidation and bullying (HIB) of students (2010, with amendments in 2012).

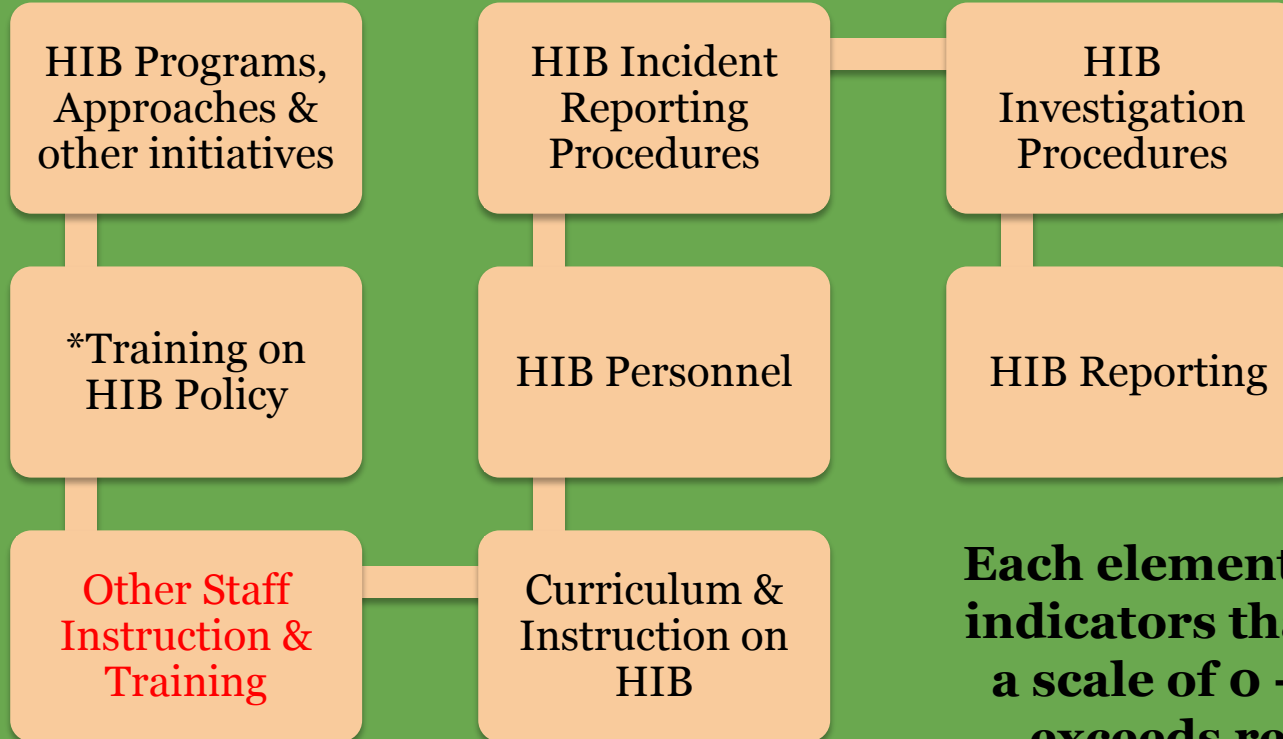
Self-Assessment of ABR/HIB

The annual Self-Assessment is intended to help the school district evaluate efforts in implementing the ABR. Through its School Safety Team, each school is required to self- evaluate the implementation of the ABR from July 1, 2019 through June 30, 2020. The Self-Assessment tool includes eight core elements that address all of the ABR requirements for schools.

Eight Core Elements Evaluated
